FINANCIAL SECTOR REGULATION ACT, 2017: AMENDMENT OF NOTICE OF COMMENCEMENT

In terms of section 305 of the Financial Sector Regulation Act, 2017 (Act No. 9 of 2017) ("the FSRA"), I, TT Mboweni, Minister of Finance hereby—

- (a) amend General Notice No. 169 of 29 March 2018, as amended by Government Notice No. 1019 of 28 September 2018, General Notice No. 142 of 18 March 2019 as corrected by Government Notice No. 657 of 10 May 2019, and Government Notice No. 1130 of 20 August 2019 by—
- (i) the substitution in paragraph (h) for the expression "1 April 2020" of the expression "1 April 2021", wherever that date appears, other than in relation to the consequential amendment repealing the Financial Services Ombud Schemes Act, 2004 (Act No. 37 of 2004);
 - (ii) the substitution in paragraph (h), in relation to the consequential amendment repealing the Financial Services Ombud Schemes Act, 2004 (Act No. 37 of 2004), for the expression "1 April 2020" of the expression "31 December 2020"; and
- (b) repeal paragraph (b) of Government Notice No. 1019 of 28 September 2018, as amended by General Notice 142 of 18 March 2019 as corrected by Government Notice No. 657 of 10 May 2019, and amended by Government Notice No. 1130 of 20 August 2019, and determine that Chapter 14 (sections 175 to 217) of the FSRA takes effect on 1 June 2020.
